15. **PROP 479**. **Proposition 479 is a result of SB 1102, which was passed in 2023**, requiring "that the Maricopa County Board of Supervisors call a countywide election for the continuation of the county transportation tax at least two years before the expiration of the tax, and shall conduct that election on a consolidated election date no less than one year before the expiration of the tax."
